Notes:

- Generally, fees for the review of an application and supporting reports are to be received before formal written comments will be provided. See CRCA Technical Report Review Services Fee Schedule for applicable fees for the review of technical reports.
- Plan review fees may be reduced with the approval of the CRCA Supervisor of Development Review.
- Significant amendments to an application or a resubmission within a period of 2 years will be charged a review fee of 50 percent of the current fee. A resubmission after 2 years will be considered a new application and will be subject to the full current fee.
- Minor refers to applications that are generally minor in nature (e.g. single family residential).
- Standard refers to applications that are generally larger in scale than minor applications (e.g. small commercial, less than 0.8 ha, additions up to 200 square metres).
- Major refers to applications that are major development projects (e.g. multiple residential, industrial).

Environmental submissions are prepared by an environmental consultant with relevant experience in wetland, wildlife habitat, and woodland ecology and species at risk. CRCA review involves evaluation of these submissions in consideration of applicable guidelines and legislation.

- Brief Reports are typically those prepared in the form of a letter of opinion generally relating to the development of a single residential lot.
- Standard Reports are typically those prepared for smaller scale subdivisions, commercial, industrial, or institutional developments.
- Major Reports are typically those prepared for larger scale subdivisions, commercial, industrial, or institutional developments, or may include the integrated assessment of multiple topics.
- The applicable report fee includes the review of one resubmission. A 50% surcharge is applied for additional submissions.
- These fees are not subject to taxation.
