The Planning and Operations Committee of the City of Brockville will be holding a Public Meeting to give the public an opportunity to make representations concerning proposed Amendments to the City of Brockville Official Plan and Zoning By-law 050-2014.

**SUMMARY OF PROPOSAL:**

- Subject property:** 1803 County Road 2 – St. Lawrence Lodge
- Description of lands:** Part of Lot 6, Concession 1, County of Leeds, now in the City of Brockville, being Part 1 on RP 28R-660.
- Proposal for the lands:** The proposal for the land is to remain as St. Lawrence Lodge - Nursing Home; however, now located within the City of Brockville.
- Proposed OP change:** Residential, in part, and Natural Hazard, in part (Township of Elizabethtown-Kitley Official Plan) and Rural Lands, subject to Natural Heritage “6E” Policies, Flood Plain Policies, Highly Vulnerable Aquifer Policies and Wildfire Hazard Policies (United Counties of Leeds and Grenville Official Plan) to Institutional Area, subject to the Cataraqui Region Conservation Authority Screening Area Policies (Brockville Official Plan).
- Proposed zoning change:** Change from I-Institutional Zone (Elizabethtown-Kitley By-law No. 13-21) to I1-General Institutional Zone (City of Brockville Zoning By-law 050-2014).

The subject lands are not the subject of any other application under the Planning Act at this time.

All public comment concerning the proposed amendments shall be heard by the Economic Development Planning Committee at this Public Meeting. Any person may attend this public meeting and make written or oral representations either in support of, or in opposition to, the proposed Amendments. **Written submissions** from persons not attending the meeting should be received by the Director of Planning, Planning Department - City Hall, One King Street West, P.O. Box 5000, Brockville, Ontario, K6V 7A5, **21 August 2019**.

Written requests for notification of the adoption of the proposed Official Plan and/or Zoning By-law Amendment, or refusal of the request, must be made to the Director of Planning for the City of Brockville at the address provided above.

If a person or public body does not make oral submissions at the public meeting or make written submissions to the City of Brockville before decisions are granted respecting the proposed amendments, the person or public body:

- is not entitled to appeal the decisions of the City of Brockville to the Local Planning Appeal Tribunal; and
- may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the board, there are reasonable grounds to do so.
