SECTION A

THINKING ABOUT STARTING A BUSINESS IN BROCKVILLE?

1

Home-based or a commercial space?

Businesses that are operating out of a home location are required to notify the Planning Department by submitting an application. There are rules about how much space in your home can be used for commercial purposes.

Register your Business Name with the Province of Ontario and get a Federal Business Number.

Complete your Business Name Registration and Title Search online through Service Ontario. Registering with the Canada Revenue Agency (CRA) is required for interactions with the Federal Government regarding GST/HST, Payroll, Corporate Income Tax, & Import/Export Accounts. Leeds Grenville Small Business staff can provide more information and help guide you through the process.

Are you a small business looking to get started?

Register your Business with the City of Brockville

While Brockville does not have a formal business licensing program, certain types of businesses do need a specific permit to operate (see Section B #5 for a list of permits). We also like to know about new businesses in the city so that we can help promote you, understand your business mix, and assist you where we can. See Section C for more information.

SECTION B

WHEN SELECTING A SPACE FOR YOUR BUSINESS...

Is your proposed business allowed in your location?

Before you sign a lease, check your property's zoning with our Planners – they can let you know if your business is permitted at your preferred location. If it is not, they can walk you through the steps to change that, if possible, or let you know your best options.

Is your business type the same as the existing use for that space?

Are you changing the use of the space? For example, are you changing from a retail space to a restaurant? You must register the Change of Use when changing the type of business the space will be used for, even if that business type is allowed under zoning. This is because different types of businesses have different considerations such as number of washrooms, occupancy, or weight bearing capacity.

Will you have a sign?

Any type of sign, whether temporary or permanent, requires a permit. Signs for downtown businesses must also adhere to the downtown requirements under the sign bylaw on materials and design.

Are you planning any work to the property?

Moving things around? Adding or removing anything? Most work requires a building permit, and that's a good thing! That means our inspectors will be checking the work along the way to make sure everything is done properly and meets the Ontario Building Code, which protects your long-term goals. Check with us before you start work to ensure that you have the correct permits in place and to tap into their expertise before you start work. Work without a permit can result in fines and delays that can be costly to your business and your goals for opening.

Do you need a Municipal Permit?

While a municipal business license is not required for most businesses, certain types of businesses do require a permit, including:

- Refreshment Cart (public or private property)
- Door to Door Sales
- Transient Trader Licence
- Busking Licence
- Sidewalk Patio Licence. This licence is needed if a portion of your property is encroaching onto City property and will be used for a patio for your establishment. (Typically, those applying for this license would be restaurants wishing to have patios on the sidewalk in front of their establishments on King Street).
